OUTREACH ACTIVITIES

Blackleggs Creek Watershed Association is managing a PA DEP Growing Greener Grant. The grant ended December 31, 2023. In February 2024, I completed the final report and filed for final reimbursement request. I also completed updating all water quality sampling data taken by KC Stream Team from 2022-today into a database. Blackleggs Creek Watershed Association is interested in applying for a BIL/IIJA AMD/AMD grant for the continuation of the work being done in the watershed.
